#### > New Business

#### a) Phase II Construction

Mr. Black discussed our need for more classrooms along with four new teachers. The construction would include some demolition and exterior work. MAT is over capacity, and there is a concern that there will not be space for upcoming/existing students. This is possibly due to expanding opportunities, which is lowering our attrition rate. This growth will also result in a need to evaluate our parking lot at a later date. Mr. Peeples clarified the net gain in revenue by adding 125 more seats and 4 teaching units. Mr. Caffey questioned if we would pay cash for this remodel and how that may impact our plans on school #4. Ms. Ehnle explained we had time to re-evaluate paying cash at a later meeting if that became a concern.
