Violations Comments

Violation #22. Cold holding temperatures

Apple slices in cold holding were observed to be 50F in serving area. Time/temperature control foods must be held at or below 41F in cold holding or time must be utilzed as a control.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #40. Personal cleanliness

Staff was observed using a visor as a hair restraint while handling food. A hat, hair net, or other effective hair restraint must be used while handling food in kitchen. This staff member put on an appropriate hair restraint during the inspection.

CODE REFERENCE: 64E-11.003(3). Employees shall wear effective hair restraints; clean outer clothing; gloves when nails are artificial, polished, or not trimmed; and not wear prohibited jewelry.

Violation #48. Ware washing: installed, maintained, & used; test strips

2 compartment sink was observed being used for dishwashing in warewashing room. One compartment had both detergent and sanitizer tubes leading to it, with the other compartment being utilized for rinsing. A 3 compartment sink with a wash, rinse, and then a sanitizing compartment is to be utilized for warewashing. A correctly functioning dishwasher was also available in dishwashing room that the kitchen manager stated was the primary means of washing and sanitizing dishes.

CODE REFERENCE: 64E-11.003(4). Warewashing facilities must be approved, available, maintained, effective, and used for cleaning and sanitizing foodcontact surfaces and equipment. Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.
