The middle dumpster was observed to have a hole at the back left corner. This dumpster must be replaced in order to be leakproof.

CODE REFERENCE: Solid Waste. 6A-2.0040(9). Garbage, trash, & rubbish shall be collected, stored, & disposed of at a frequency & in a manner that prevents a sanitary nuisance. Wet garbage shall be collected & stored in impermeable, leak proof, fly tight containers pending disposal. Outdoor waste containers must be easily cleanable & serviceable.
